168/21 HEATING AT THE CAFÉ IN THE PARK

The Town Clerk advised members that since the flood last year, there has been no heating in the café. Some of the heaters had already broken and some were damaged in the flood.

Various options have been explored. Stockton Borough Council attended the site and advised that the best option would be to upgrade the current gas boiler in the annexe and run the pipework through to the café and install new radiators. This would be at a cost of approximately £8500 plus a design fee of 15%.

The Town Clerk expressed concerns over this cost and that the Town Council had already paid over £7000 to replace the ceiling after the flood, as Stockton Borough Council were not insured for water damage but we were not aware of this.

RESOLVED

To write to Stockton Borough Council with our concerns and request that, as it is their building and they are the landlord, they pay for the heating installation.
